

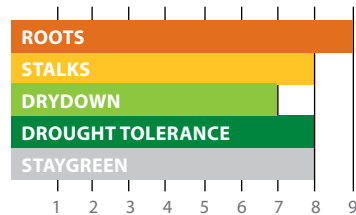

CONTINUOUS CORN MANAGEMENT

- Dual action SmartStax trait makes this a great choice for fields with a history of CRW feeding
- Monitor for foliar diseases and apply fungicide as needed, manage residue to minimize Goss' wilt risk

LEGEND: E = early for maturity, A = average for maturity, L = late for maturity; M = medium, MS = medium short, MT = medium tall, T = tall; H = high, MH = medium high, ML = medium low; F = flex, SF = semi-flex, D = determinate, SD = semi-determinate. 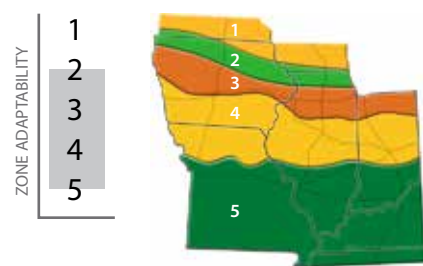
